

International Cooperation Agreement between Inercia Digital and Independent private higher education institution Banja Luka College

This Partnership Agreement (the "Agreement") is made and entered into on the 27th day of October, 2021 (the "Execution Date") by and between the following Parties:

Inercia Digital S.L., ID E10145080 with address in Parque Científico y Tecnológico de Huelva (PCTH, Cauchy, 1, Edificio 2000, 21110 Aljaraque, Huelva), Spain, represented by Caridad Martínez Carrillo de Albornoz, and

Banja Luka College – BLC, Private Higher Education Institution, Milos Obilic Street 30, 78 000 Banja Luka, Republic of Srpska, Bosnia and Herzegovina, represented by Nenad Novakovic

Background

- A. The Partners wish to associate themselves as partners in European proposals, specifically in The new Erasmus Programme 2021-2027.
- B. This Agreement sets out the terms and conditions that govern the Partners within the Partnership.
- C. This Agreement sets up a collaborative relationship between an organisation established in a Programme Country and an organisation established in a Partner Country.

IN CONSIDERATION OF and as a condition of the Partners entering into this Agreement and other valuable consideration, the receipt and sufficiency of which consideration is acknowledged, the Parties to this Agreement agree to the following:

Terms and conditions of the agreement

Article 1. Creation of Partnership: By this Agreement, the Partners enter into a general partnership (the "Partnership"). The rights and obligations of the Partners will be stated throughout this agreement.

Article 2. Purpose of Partnership: The Partnership is established for the following purpose: to



create collaborative relationships around European innovation proposals, specifically, for The new Erasmus Programme 2021-2027, in order to strengthen a long-term relationship between member countries (Spain – Bosnia and Hercegovina) in order to fight against the educational needs of our countries, exchanging good practices, methodologies, tools and offering inclusive and environmental learning. As stated in EU Council communication statement release on December 2020, priorities of this programme are:

"achieve cooperation, quality, inclusion, creativity and innovation at the level of organisations and policies in the field of education and training, youth and sport. Further to that, Erasmus+ will support teaching, learning, research and debates on European integration matters, including on the Union's future challenges and opportunities" (Eu Council)

Article 3: Tasks: Throughout the Term of this Agreement, at its expense, the tasks for both parties will be:

Help BANJA LUKA COLLEGE in the look of some Spanish organisations it may need for the creation projects consortium.	Help Inercia Digital in the look of some Spanish organisations it may need for the creation projects consortium.
Conduct dissemination actions of the collaborations established.	Conduct dissemination actions of the collaborations established.

Article 4. Duty of Loyalty: The Partners will be hereby indemnified in respect to losses, damage, costs, liabilities, and all other expenses which may arise due to breach of "Duty of Loyalty" clause and shall only be borne by the partner in contravention of this tenor. In addition, both parties express his commitment to confidentiality and acknowledges not only the obligation for keeping professional secrecy with regard to personal data and other confidential information to which he/she may have access to by previous authorization, but also the adoption of duties and obligations concerning personal data processing, in accordance with the Organic Law 03/2018 of 5 December, on Data Protection and Guarantee of Digital Rights.

Article 5. Term: The partnership's existence shall commence on 27. 10. 2021. and shall continue until dissolved either by mutual agreement or by operation of law. The period of



validity of the Agreement shall be annual, tacitly extendable if the grouped entity does not give written notice to the contrary, at least one month before the end of the annual period of validity. However, in the event of a breach of any terms of this Agreement, either party may terminate this Agreement by giving the other party 30 days written notice provided said notice shall set forth the breach being claimed as the basis for termination.

Article 6. Forbidden Acts:

- A. Partner cannot and may not do any act in contravention of this Agreement.
- B. No Partner may do an act that would make it impossible to carry on the ordinary business of the Partnership.
- C. No Partner may confess a judgment against the Partnership.
- D. Any violation of the above Forbidden Acts will be deemed an involuntary withdrawal of the offending Partner and may be treated accordingly by the remaining Partners.
